

Owner Consent Form to Perform Veterinary Physiotherapy:

1. Treatment by **Abbott Veterinary Physiotherapy** will not commence without prior authorisation from their Veterinary Surgeon, unless for maintenance cases.
 - I hereby certify that my Veterinary Surgeon has given permission for physiotherapy treatment to be performed on my animal. I give permission for the Veterinary Physiotherapist to discuss treatment with my Veterinary Surgeon and understand that the Veterinary Physiotherapist may refer my animal back to the Veterinary Surgeon.
 - It is the owner's responsibility to declare any change to the animal's condition in between treatments.
2. Whilst every care is taken of the animal during Veterinary Physiotherapy treatment, it is done so at the owner's risk.
3. Animals with infections or contagious conditions will not be treated. It is the owner's full responsibility to inform of any such conditions, prior to treatment. Animals should be clean prior to treatment.
4. Owners are required to contact Abbott Veterinary Physiotherapy if, between treatments, the animal's injury or condition worsens, or if the Veterinary Surgeon advises that treatment is stopped or suspended.
5. Abbott Veterinary Physiotherapy reserves the right to refuse treatment to any animal. Freya Abbott reserves the right to stop the treatment if animals are behaving dangerously during treatment, or if further Veterinary assessment is required prior to further Veterinary Physiotherapy treatment. Charges will still apply.
6. Payment methods accepted include cash and bank transfer. Cash payments are required at the time of treatment. Bank transfers must be paid within 1 week of treatment and / or invoice. Late payments will incur a fee of £5 per week past the original due date.
7. Owners are requested to provide adequate equipment (head collar, lead rope / collar, lead) and are required to be present at all times during the animal's treatment session.
8. Abbott Veterinary Physiotherapy reserves the right to use video footage and photographic images taken during treatment sessions. This may be used for educational, informative, or marketing purposes.
9. Abbott Veterinary Physiotherapy cannot be held responsible for any loss or damage to vehicles or personal property, whilst on the premises.

10. Abbott Veterinary Physiotherapy does not take any responsibility for any accident/ injury sustained by the animal's owner or the animal whilst the animal is undergoing veterinary physiotherapy treatment.
11. Abbott Veterinary Physiotherapy operates with the adequate qualification and insurance.
12. Please note that appointments should be cancelled at least 48 hours prior to the time. In the case of appointments being cancelled with less than 48 hours' notice, charges will still apply for the lost time.
13. Following Veterinary Physiotherapy treatment, animals will often require a period of rest, often around 24 hours. This will be discussed following treatment, however Veterinary Physiotherapy sessions should be booked with this knowledge in mind.
